You see, we believe that by renovating their new pub and restaurant in Bordentown, NJ, **DUBLIN SQUARE IRISH PUB AND RESTAURANT has endorsed lower wages, fringe benefits, and living standards for Burlington County** residents by contracting with an electrical contractor that **does not pay** it's employees the area standard for wages and fringe benefits. We believe that owners **MICHAEL AND SEAN MCGEOUGH** are responsible for this decision.

We further believe, if such contractors continue to be supported by construction users like Dublin Square Irish Pub and Restaurant; wages, fringe benefits, and living standards in Burlington County will most likely drop, and **YOU could end up working for less** than you presently earn. This begs the question: **can you afford to live on less**? We believe the answer is obviously NO. However, in this regard, Dublin Square Irish Pub and Restaurant seems totally unconcerned about our collective welfare; and with your help, we hope to change that attitude.

Please don't allow Dublin Square Irish Pub and Restaurant / Michael & Sean McGeough to destroy the area standards for wages and fringe benefits by and through contracting methods that are insensitive to the quality of life for residents of Burlington County.

Please tell your family, friends, and neighbors what Dublin Square Irish Pub and Restaurant has done. WE URGE YOU to not patronize Dublin Square Irish Pub and Restaurant until they agree to change their contracting methods to include provisions that require electrical contractors, with whom Dublin Square Irish Pub and Restaurant contracts, to pay employees the area standard for wages and fringe benefits as established for BURLINGTON COUNTY, NJ.

We believe that if **Dublin Square Irish Pub and Restaurant refuses to change** its contracting methods and attitude, **Dublin Square Irish Pub and Restaurant will prove it is not a good neighbor** and is simply interested only in promoting corporate greed and other selfish interests rather than the welfare of the Burlington County families and perhaps others, it seeks to have as its patrons.

Please advise Owners, **Michael & Sean McGeough** of Dublin Square Irish Pub and Restaurant that you **will not support corporate indifference** to the future-welfare of Burlington County residents by patronizing Dublin Square Irish Pub and Restaurant until it changes its attitude and contracting methods.
